The new Supreme Court of Virginia Judicial Learning Center will tell the story of Virginia's judiciary history, providing a valuable educational resource for visitors to the Supreme Court building, which include elementary and high school students, leadership groups, civil organizations, and individuals from every corner of the state. A professional museum design firm will be retained to design, fabricate, and install graphic panels, exhibits and casework that will provide an interactive and memorable learning experience that highlights the rule of law and why an independent judiciary is important to a democratic society.

Featured Story: The Virginia Law Foundation Fellows Program

The Virginia Law Foundation Fellows Program encourages civic-mindedness and recognizes leaders in the profession, not just in their practices but in their communities. Our Fellows comprise a group of nearly 500 of Virginia's best and brightest legal practitioners committed to the concept of citizen lawyer.

According to John D. McGavin (Fellows Class of 2006), a Principal and Managing Partner at Bancroft, McGavin, Horvath and Judkins, PC in Fairfax, who serves as the Chair of the Foundation's Fellows Committee, "Attorneys that are selected are preeminent practitioners who find a way to add to their busy schedules an outstanding commitment to promoting our profession to its highest and best purposes. That means professionalism, serving the community and giving back, offering pro bono services, and promoting access to justice."

Fellows are nominated confidentially by their peers during the annual nomination period that runs February 1 – June 15. Candidates must meet the following criteria to be eligible for nomination:

- Be an active or associate member of the Virginia State Bar for at least 10 years
- Be a resident of Virginia

- Be a person of integrity and character
- Have maintained and upheld the highest standards of the profession
- Be outstanding in the community
- Be distinguished in the practice of law
- Retired and senior status judges are also eligible
- Sitting full-time judges are not eligible during their tenures

“These folks succeed as lawyers, they succeed at making the profession better, and on top of that, what makes this group remarkable is their commitment to the community,” said McGavin. “It’s amazing what they contribute in ways you never would have expected.”
